## Spelthorne Council Officers to give presentation on Cattle Grazing in Sunbury Park at this year's AGM

Although we are very fortunate that our meetings are generally well-attended by residents, usually because there is rarely a shortage of important issues to discuss. However, we always try to have a special feature at our Annual General Meetings to make them something of an occasion and to provide those who make the effort to come with some special insight or interest.

This year we decided to make Cattle Grazing in Sunbury Park our topic for a presentation and discussion, because not only is it clearly an issue which has caused residents some concern but also because there has been a distinct shortage of information and background available to residents.

When this proposal first came up a couple of years ago, as reported in previous LOSRA newsletters, Spelthorne's officers had undertaken to Friends of Sunbury Park that before any decision was taken, a consultation would take place which would involve bringing a couple of the cows in question into the Park for a weekend under supervision, with an associated exhibition of

the proposal's implications and Council officers and someone from Surrey Wildlife Trust, who manage the herd, available to answer questions. Unfortunately, for whatever reason, this didn't happen, and we understand that Spelthorne committed themselves to the scheme because there were deadlines for applying for the funding for infrastructure changes needed in the Park—gates, fences etc..

As a result there have been all sorts of rumours and misinformation flying around, and some worrying indications of shifts in position—for example, where originally the Friends of Sunbury Park were told that the cows could happily co-exist with dogs, story in Sunbury Matters with Spelthorne's Biodiversity Officer referred to restrictions on dog walkers.

We though it was time to get everything out into the open and make all the facts, timings and implications available to residents, so this is your chance! Jackie Taylor and David Hicks from Spelthorne Council have kindly agreed to come to the meeting to give a presentation and answer questions. We are grateful to them for their input, and we are sure there will be a lively discussion.

## Carden Party Sunday 16th June 12-5pm at The Old Vicarage, Church Street

As noted in our Spring newsletter, LOSRA is repeating the Garden Party which we inaugurated last year in the grounds of the Old Vicarage in Church Street at the invitation of the owners Mr. & Mrs. Michael Heslop, who kindly made it available for a fundraising event in appreciation of LOSRA's work on behalf of the community, and to celebrate LOSRA's 40th Anniversary.

Mr. & Mrs. Heslop have generously repeated the invitation this year, and since it was so successful, we are doing it again, on Sunday June 16th from noon until 5pm. This is Father's Day, so it's an opportunity for an enjoyable family occasion.
